

# **Development Assistant**

*Part-Time (5-10 hours/week)* 

The Connecticut Veterans Legal Center (CVLC) is seeking a **Development Assistant** to support the ongoing administrative needs of the Development and Communication team. This person will play a critical role in the success of the department, which raises \$2.5 million annually to ensure all low-income Veterans in Connecticut have access to free legal services.

### Primary Roles & Responsibilities

- Manage gift processing and the donor database (Salesforce), including data entry for all contributed revenue (including individual, corporate, grant, and contract income)
- Prepare reports and mailing lists as required
- Data Hygiene, including periodic clean-up of Salesforce
- Prepare donor acknowledgment letters for mailing (letters and envelopes), using provided templates
- Track grant application and report deadlines
- Support administrative needs for special events (The Ride for Our Vets, Saluting Service, private donor events, etc.)
- Provide additional administrative support for Development and Communications department, as needed

## **Required Skills and Experience**

- Experience with Data Entry and fundraising software, tech savvy and adaptable to new platforms—experience with SalesForce a strong positive, but not required
- Keen attention to written detail and Standard American English Grammar
- Familiarity or ability to learn Google Suite (Google Calendar, Google Sheets, Gmail)
- Familiarity or ability to learn Microsoft Office suite (Excel, Word, MailMerge)

<u>Compensation</u>: This is a part-time (5-10 hour/week) position, paid hourly at **\$20-25/hour** based on candidate's experience and skill level at time of hire. Because this position is part-time, <u>no</u> additional benefits are provided.

Location: CVLC's Admin Office, 265 Church Street, New Haven CT

\*Hybrid/partial work from home schedule is possible for a candidate with proven experience. Candidate must be based in Connecticut and be prepared to work in-person for all or a portion of their work. **Schedule:** Final work schedule to be determined upon hire to fit the needs of the organization and the candidate. This role is expected to work 2-3 days a week, but hours may be spread across 5 days a week.

Veterans, Military Spouses, and other members of the military community are strongly encouraged to apply. Studies have shown that women, members of the LGBTQ+ community, and Black, Indigenous, People of Color (BIPOC) individuals are less likely to apply for jobs unless they believe they meet every single one of the qualifications as described in a job description; despite the reality that applicants rarely ever meet 100% of the qualifications.

We are committed to building a diverse and inclusive organization, and we are most interested in finding the best candidate for the role. That candidate may be one who comes from a background less traditional to our field of work, and that's okay! <u>We strongly encourage you to apply, even if you don't believe you meet every one of the qualifications described.</u>

**About CVLC:** We are a dynamic group of client-centered advocates. The results we get for our veterans are some of the best in legal aid, and we all play a part in making that happen.
